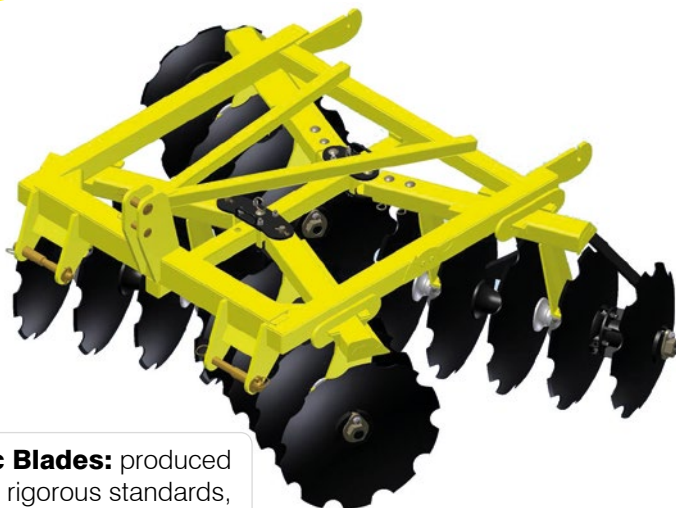

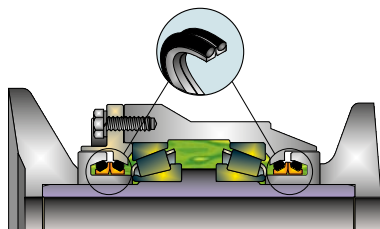
Disc Blades: produced with rigorous standards, they offer superior resistance to wearing and impacts.

- Main frame made of tube with uniform load distribution.
- Several adjustment points allow a great performance in different types of soil.
